#### Session Overview:

The Patient Protection and Affordable Care Act (PPACA) includes provisions for the utilization and administration of biosimilars which, by definition, are biopharmaceutical agents that may be classified as therapeutically but not generically interchangeable. This session will explain the scientific process used to produce biopharmaceutical agents, discuss the PPACA and its impact on the evaluation and approval of biosimilars in the United States, discuss the risks of biosimilars utilization and how these risks can be mitigated, how biosimilars should be evaluated for formulary inclusion, educating other health care professionals on biosimilars substitutions, and how doctor of pharmacy curriculums can best prepare students for practicing in this environment.
